WILL HAVE BERDING AND WEIL DRAFT PROMISSORY NOTE FOR BOARD MEMBERS TO SIGN BY DOCUSIGN AND FUNDS WILL BE DISTRIBUTED IN TO OPERATING ACCOUNT BY END OF MONTH. THIS ACTION ALLOWS THE ASSOCIATION TO RECOVER FROM THE COST OVERRUN ON THE POOL AND TRELLIS REHABILITATION. THIS PROVIDES THE ASSOCIATION WITH RELIEF FROM A SPECIAL ASSESSMENT.
